Each job or category of jobs for school staff that involves child-connected work must have a clear statement that sets out:</p> <p>a. the job’s requirements, duties and responsibilities regarding child safety; and</p> <p>b. the job occupant’s essential or relevant qualifications, experience and attributes in relation to child safety.</p>	<ul style="list-style-type: none"> • Information packages includes role description and child safety policy and code of conduct • Applicants must complete an application form which outlines experience and relevant qualifications • All qualifications are checked eg certified copy of transcript of results 	<ul style="list-style-type: none"> • Information packages • Application Forms • Advertisement materials

<p>4. In accordance with any applicable legal requirement or school policy, the school must make reasonable efforts to gather, verify and record the following information about a person whom it proposes to engage to perform child-connected work:</p> <p>a. Working with Children Check status, or similar check;</p> <p>b. proof of personal identity and any professional or other qualifications;</p> <p>c. the person’s history of work involving children; and</p>	<ul style="list-style-type: none"> • Applicants must provide current WWCC or VIT registration- This checked against register • 100 point of identification required eg licence, passport and one other. • Referee check to verify work history- information recorded and kept in applicant file 	<ul style="list-style-type: none"> • Register- WWCC and VIT • Staff file- copy of identity, qualifications etc
